CR-0006 Change Request PD exit site tunnel infections

Members **DISCUSSED**:

- The introduction of reporting PD exit site tunnel infection as an ongoing collection to the ANZDATA survey now that TEACH-PD has closed. Members agreed this is valuable to collect but noted the increased data burden with the introduction of new variables. **SM provided data related to current reporting of PD infections to members**
- **Members NOTED several questions** that will need further consideration from the PD WG with assistance of ANZDATA: Exit site infection or tunnel infection that turns into peritonitis how that would be reported, PD solution at time (relevance), data entry burden and route of antibiotic administration.
- **NOTED**: JC hopeful of a timeline of January 2026. ANZDATA advised timeline would be depending upon the workload for the software development.

Members AGREED: To the change request with the agreeance PD WG to work with ANZDATA to finalise finer detail.
